INTRODUCTION

Kaplan made an early contribution to the development of double-indexing semantics, but his explanation of what he calls the conceptual distinction between context and circumstance was just as significant. Context and circumstance are only two indices in a formal sense. But they play very different roles in Kaplan's semantics (Speaks, 2009).

Kaflan proposed his opinion because he think that he must distinguish between the information being conveyed or represented and the methods used to do so. Of course, the information conveyed in an utterance—what is said—depends on the meaning of the sentence uttered, but it is impossible to separate content from meaning because what is said may also depend on other factors. In particular, what is said may depend on the information present in the context of the utterance (Recanati, Francois. 2015).

Therefore, Kaplan propose his indexical. According to him that an indexical is an expression whose reference depends on the specific assessment criteria we use when reading a sentence. Indexicals can also be thought of as expressions that, when they are part of a sentence, cause the meaning and truth value of the sentence to rely on the circumstances surrounding the sentence's evaluation. We are interested in the process by which an indexical's referent is determined in the first definition for the time being, but it will be helpful to return to truth-values later (Villena, 2018). In simply one, it can be said that An index in Kaplan's view is an expression whose reference depends on the particular circumstances in which we read a sentence. Kaplan divided indexical into two dimensions, character and content. The character of an expression is or determines a function from contexts of utterance to contents. In simply, Kaplan called character as an agent or speaker or the writer in an expression (Georgi, 2012). Then, content is the expanding information expressed by character (Braun, 2013).

Character and content has close relation each other. It can be figured out on the following picture




Figure 1. relation between character and content

As it explained by Martin that indexicality can determine the definite and indefinite description (Martin & Hinzen, 2014). It also supported by Kaplan cited in Jaszczolt, character/content should be appropriately "pragmaticized" in order to fit into this adaptable, purpose-driven category. In other words, because they correspond to "flexible" inferential grounds, characters become "fluid." (Jaszczolt, 2012). Therefore, the writer intrigued to analyze and concentrate on characters in song lyric. We knew that song is one of the most way in expressing idea, opinion and thought. Song is also a tool for human to communicate each other by sound and music. Song is another way to communicate people's feeling to someone else that is through lyrics. Human can express their various feeling and emotion by arranging of lyric accompanied by song (Thao, Nguyen Van & Herman, 2020). Moreover, song is accompanied by music to evoke listener's emotion, because music is also can be described as a "language of emotions' (Uslin P. N. & Sloboda J. A, 2010). In this study, the song lyric that I choose here entitled "a love secret" which is sung cover by Morisette. Johanne Morissette Daug Amon (born June 2, 1996), known professionally as Morissette, is a Filipino singer, songwriter and former child actress. She first rose to prominence when she was the runner-up on TV5's Star Factor at the age of 14. In 2012, she made her professional stage debut in the Repertory Philippines stage adaptation of Disney's Camp Rock in the role of Mitchie Torres. This song was popular again because of her beauty vocal and attracted the listeners. Many listeners in her youtube channel praise her vocal is better than the original singer.

In this study, the writer concentrates on the investigation of characters from song lyric by conducting of descriptive with qualitative research. The data above shows that the cooccurrences of character and content in lyric song. Kaplan divided the type of character into two; variable and fixed character. This lyric song dominantly used variable character. It can be seen from the use of I, you and we in every line of song lyric.

The use of variable characters in this song is not only a way for the songwriter to convey the feelings the experiences but also touches the hearts of other listeners. It doesn't matter whether the listener has felt the same way as in the lyrics or not. But through the use of variable characters in the lyrics of this song, it can convey the author's message through the song to the listener. Based on the analysis, it can be said that the author intentionally packaged the lyrics of the song with variable characters so that anyone who heard it could feel the situation and have a different reference. When listeners hear the lyrics of the song will refer to different references. We give an example if it is true that the author has experienced this situation, then the reference "I" refers to the author himself. Meanwhile, if the writer has never experienced the situation

(just imagination) or maybe someone else's experience, then the word "I" refers to listeners or other people who have or do not have the same experience with this song's situation.

The use of the variable character "I, you and we", it is a way of indexical to the person referred to in this song. Let's just take an example, if the singer of this song uses "you" to refer to the person he is referring to, then the reference "you" is his secret lover, who may have the names Andin, Elsa, etc. on the other hand, as a listener, the word "you" here can refers to other people. In simple terms, the use of the variable character of this song is intended for the general public or listeners who are likely to refer to different references. The use of variable characters is also a way for listeners to engage with the situation in the lyrics of the song.

CONCLUSION

After analyzing and interpreting of the data, it can be concluded that variable character is mostly dominant in this song lyric. it can be seen from the use of "I, You and We in every line of song lyrics. The use of this character is as a way to communicate between singer and listeners. It is very important for the listeners to have an idea who the other person is so they can understand the interaction between the character. The character "I, you and we" come to make a vivid life in song lyric. the listener will get a picture who, what, when and where the situation occurs.
